2. An Expert Team conducted onsite evaluation of the programs from 25<sup>th</sup> to 27<sup>th</sup> October, 2024. The report submitted by the Expert Team was considered by the concerned Committees constituted for the purpose in NBA. The Competent Authority in NBA has approved the following accreditation status to the programs as given in the table below:

3. It may be noted that only students who graduate during the validity period of accreditation, will be deemed to have graduated with an NBA accredited degree.

4. The Institution has been conferred autonomous status for a period of five years from the Academic Year 2022-23. Therefore, **Annapoorana Engineering College, NH-47, Sankari Main Road, Periya Seeragapadi, Salem-636308, Tamil Nadu** should submit fresh online application through eNBA portal under Tier I Document in respect of above three UG Engineering programs not before five months from the expiry of validity of accreditation mentioned above.

The accreditation status awarded to the programs as indicated in the above table does not imply that the accreditation has been granted to **Annapoorana Engineering College, NH-47, Sankari Main Road, Periya Seeragapadi, Salem-636308, Tamil Nadu** as a whole. 9. If the Institute is not satisfied with the decision of NBA, it may appeal within thirty days of receipt of this communication on eNBA portal alongwith Report of the Expert Team, giving reasons for the same and by paying the requisite fee.
